Achievements:

- 2006 Reclamation Project: Managed 608 acres of reclamation projects in a 4 month period. It was essential to complete this project as per our federal permit. Included the placement of over 1,223,000 cubic yards of material. Completed the project on schedule and under budget.
- Inspected and managed 15 multiple pond impoundment systems weekly under MSHA guidelines for a period of 5 years. During that period, no citations were issued for faulty inspection or reporting.
- Managed the construction of the pond 46 system. The contractors assigned had a short time span and remote challenging topography to construct the system. Worked closely with company and contractors to complete this \$2,000,000 project despite record rainfall in the month of August.
- Earned a Managers Award in 2003 for reclaiming more land in one summer than the mine disturbed in one year. This was a first in the 32 year history of the mine.
